**ALL SHOWS NEED A BBCR Representative present at the show**

Host Requirements: **Initial** \_\_\_\_\_

- Application for BBCR Club/ Kennel must be received before your show date can be scheduled.
- The hosting Club must contact the Judge and Representative in order to go over the details of hiring them to work the show. Please refer to the Host/Judges Agreement form for all details.
- The hosting club will work with our Show Committee to ensure a well ran and promoted show. Any question please feel free to contact our committee.
- Judge's and Representative's travel arrangements and accommodations must be secured with our offices no less then 14 (calendar days) before the event
- Hosting Club will provide adequate staffing for the BBCR Representative to conduct a smooth flowing show.
- Hosting Club is required to purchase event insurance. The BBCR must be provided with a copy of the insurance certificate within 30 days of the show date.
- Club must provide the Judges and Representatives with the proper tools to perform their duties. This covers anything from show numbers, to pens, to water in the ring, etc...
- Not adhering to these Terms and Conditions would be cause for a ONE year Club hosting suspension and could result in permanent loss of hosting abilities.

Fees: **Initial** \_\_\_\_\_

- \$100.00- BBCR Sanctioned Show -\$50.00 any extra show. (60 days prior to event date) (2 Show Limit)
- \$25.00- Penalty if Host Requirements are not met.
- \$150.00- BBCR Official Representative Fee -\$25.00 any extra Breed (due day of the show) \*plus travel expenses (travel must be paid two weeks prior to show date)
- \$200.00- BBCR Certified Judge Fee -\$50.00 extra for BIS Judge, when at multi-breed show (due day of show) \*plus travel expenses (travel must be paid two weeks prior to show date)
